

Pets Get Physical Inc.
Doggy Daycare, Boarding and Grooming Care Agreement

I, _____ (Owner/Guardian) certify that I am responsible for the following animal(s) listed below and in consideration of the services to me given by Pets Get Physical Inc., I agree as follows:

I understand that Pets Get Physical Inc., has relied upon my representation that my dog is in good health and has not been exposed to rabies or any parasite or contagious infection. I give consent to Pets Get Physical Inc., to contact my regular veterinarian to confirm my pet's health and vaccinations and hereby authorize my veterinarian to release those records to Pets Get Physical Inc. I confirm that my pet(s) has not injured or shown aggression or threatening behaviour to any person or dog in admitting my dog for care at their facility.

I understand that Pets Get Physical Inc., their owner and staff, will not be liable, financially or otherwise, including but not limited to, lost or misplaced property, illness, any injury, damage, loss or from any pre-existing health condition of my pet(s) which is known or unknown to Pets Get Physical Inc. I hereby release Pets Get Physical Inc., of any liability of any kind from my dog's participation in any and all services provided by Pets Get Physical Inc.

I understand there are some risks and benefits associated with group socialization of dogs in an open concept environment. I agree that the benefits outweigh the risk and that I accept the risks. I desire a socialized environment for my dog while attending services provided by Pets Get Physical Inc., and while in their care. I understand that while socialization and play is closely monitored by Pets Get Physical Inc., it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dog will be pointed out by staff upon pick up. I understand that some play can turn into an altercation and even though Pets Get Physical Inc., does everything to avoid these scenarios, they do occur and I will not hold Pets Get Physical Inc., responsible for my dogs or another dogs actions which cause injury.

In the event an emergency should occur with my pet(s) of the state of my pet(s) health requires professional attention, I authorize Pets Get Physical Inc., in its sole direction acting responsibly, the right to administer first aid and/or engage the services of any veterinarian on my behalf. I further agree to assume full and sole responsibility of any and all costs thereof.

I have read the fee structure and agree to pay all charges at the time of check out. Should my pet(s) not be picked up by the prearranged date and time of check out, I authorize Pets Get Physical Inc., to take whatever action deemed necessary to continue the care of my pet(s) and I will pay all costs and charges that apply. If my pet(s) has not been picked up within 14 days of the prearranged date and time, I authorize Pets Get Physical Inc., to release my pet(s) to the proper authorities who will then be the animal's sole representative.

I understand that my pet(s) may be videotaped, photographed or recorded while under the care and management of Pets Get Physical Inc. And that they shall be the exclusive owner to the results and proceeds of such taping, photography and recordings with the rights to unlimited use.

I will abide by the rules and regulations set out by Pets Get Physical Inc.

This Care Agreement covers the current relationship between Pets Get Physical Inc., and me. Each time I bring my pet(s) to Pets Get Physical Inc.'s facility I affirm to the terms of this Care Agreement.

I certify that I have read and understand this Care Agreement, including the policies and procedures set forth and accept all the terms and conditions of this Care Agreement.

Additional Information to be Aware Of:

Health

All guests must be current (within one year) on their regular vaccinations (a copy of certificates must be provided at the time of check-in). We also require our canine guests have the Bordetella (Kennel Cough) vaccine. We do recommend that your dog be on a flea preventative maintenance program. No guest will be admitted without proof of vaccinations and if we discover they have fleas. For the safety and well being of all our guests we require that they be free of contagious diseases upon check-in.

Safety

As long as your pet is in it's indoor/outdoor run, it is at Pets Get Physical Inc., highest level of safety. Due to the fact that dogs will be dogs and due to the physical nature of outdoor play, injuries can occur beyond our control and Pets Get Physical Inc., cannot be held responsible. The owner must also be held responsible for all their animals' aggressive actions towards other pets.

Illness

Just as humans contact illnesses from being in contact with other people, animals too can acquire "pet colds". At Pets Get Physical Inc., we do everything we can to prevent your pet from catching a cold, unfortunately however, pets can still become ill. Pets Get Physical Inc.'s staff cares a great deal about your pet while they are boarding and hate to see anyone come down with an illness while boarding or once they return home. Pets Get Physical Inc.'s staff is trained to handle and treat most minor illnesses. Typical illnesses that may occur during or just after boarding include diarrhea or coughing. Diarrhea is treated using Metronidazole. At Pets Get Physical Inc., we can also treat any incidences of coughing with common cough syrup. Should either of these illnesses persist during your pet's stay, we will take your pet to seek veterinary care at your expense. Pets Get Physical Inc., tries to operate at the highest level of health. Should any conditions arise after getting your dog home, please notify Pets Get Physical Inc., so we are aware of the situation.

Emergencies

In the event of an emergency concerning your pet, Pets Get Physical Inc. would take your pet to your regular veterinarian in most cases (as they are familiar with your dog and have your dog's history on file), but in time dependent emergencies, our staff will take your animal to the closest veterinarian we can get them to. In such cases, you would be responsible for any costs incurred by Pets Get Physical Inc., in treating and/or hospitalizing your pet.
